ENROLMENT APPLICATION FEE

Required with Enrolment Application (inc GST, Non-refundable): \$300

CONFIRMATION FEE

Required to confirm a place when offered by the School (Non-refundable): \$4,000

CLERGY DISCOUNTS

Special provision may be made for the children of full time, ordained Ministers in certain circumstances. Application for a Clergy Discount should be directed to the Principal.

Where more than one discount applies, only the greater discount is applicable.

SUNDRY CHARGES

Sundry charges will appear on Fee Statements when optional activities such as instrument hire, Duke of Edinburgh's Awards, overseas/domestic tours, EVET courses etc. are participated in or there is a charge imposed for lost or damaged school items.

FINANCIAL HARDSHIP

Fee relief may be offered on the basis of demonstrated financial hardship and/or need. If genuine financial difficulties are experienced by a family at the School, please contact the Business Manager.

GST

Under current law, GST is not payable on Fees relating to tuition. If applicable, the School reserves the right to apply GST in accordance with legislation current at the time.

UPFRONT ANNUAL TUITION FEE DISCOUNT

The School Council is offering a 2% discount on Annual Tuition Fees when paid in full on or prior to the Term 1 due date. This discount is separate to the Fees In Advance program. The upfront annual tuition fee discount is available for 2026 only but may be subject to future consideration by School Council. FEES IN ADVANCE

The School offers options for the payment of more than one year's Tuition in advance. Details are available from the Business Manager, noting the close date for this option is end of Term 2, 2026.

BUILDING FUND

Future development of the School relies to a considerable extent on money raised through voluntary contributions to the Building Fund. Building alterations, minor building projects, major renovations and new buildings are made possible by Building Fund donations.

Parents and Guardians are encouraged to contribute \$325 per term per family to the Building Fund, or more when their circumstances allow them to do so.

Contributions to the Building Fund are fully tax deductible. Receipts are issued at the end of each financial year.

FEE PAYMENT

Fees can be paid online at www.arden.nsw.edu.au, click on Payments. Please provide the Account Number shown on the top right hand side of the Fee Statement and the family surname when making payments.

ENROLMENTS

The Enrolment Application Fee and Confirmation Fee are paid as part of the online enrolment application process.

Please note that the party(s) who sign the Conditions of Enrolment assume 'joint and several' liability to pay all fees and charges.

CHARGES AND PENALTIES

Payment of Fees by credit card attracts a surcharge. Applicable bank fees will be charged to Fee Statements for dishonoured transactions.

If Fees are not paid on time, nor an agreed payment plan in place, an Administration Fee of \$75 will be applied to the Fee Statement. Should there be continued failure to clear the balance outstanding, the School is entitled to charge a fee on the balance outstanding. The fee is equivalent to the average rate paid by the School on its debt facility per month.

If applicable, the current debt facility rate may be obtained from the Business Manager. The School is also entitled to pass on any fees and charges incurred through subsequent referral to a third party collections agency.

Please note that if an account for Fees and/or charges is not paid in full by the end of the term in which they are due, and in the absence of a mutually agreed payment arrangement, the Student's enrolment may be suspended.

Consideration for inclusion and/or participation in overseas/ domestic tours is conditional upon the Account being up to date.

WITHDRAWAL

It is a Condition of Enrolment that one full term's notice of withdrawal of a student be given in writing to the Principal. A full term's Tuition will be charged in lieu of this notice, in addition to all other fees payable. The notice must be given no later than the first day of the student's final term.
